Professional:

10% gross of the box office per performance

2. For scripts: Once you are approved and your performance right fees are paid in full, the author, Melissa Pilgrim, will provide a PDF copy of the manuscript by email for you to print out yourself. You are then allowed to make enough copies of the script for your group on your own. (Please note that photocopying scripts of *Our Holiday Show!* without approval and permission is prohibited and a violation of copyright laws.)
